20-24 October 2015, Cuiaba, Brazil

## Draft Program

### **Monday, Oct 20: Sharing and reflecting on our experiences with strategies to reduce deforestation and promote sustainable landscapes**

#### **Activity 1: Introduction – general updates on the context after the UN New York Climate Summit with the Tropical Forests Declaration and in the run up to Lima and Paris COPs of the UNFCCC**

Format: 1 plenary session with 1 or 2 panelists

#### **Activity 2: Thematic experience-sharing panel sessions**

Format: 4 panels with up to 4 short presentations each, followed by a discussion

The themes of the panels will be defined through aggregating/ summarizing the following items:

- 1) Payments for ecosystem services such as biodiversity, water; Forest conservation incentive programs that strengthen sustainable resource use and livelihoods of local communities

## **Tuesday, Oct 21: Building an updated understanding of REDD**

### **Activity 3: Breakout group discussions to develop our understanding on key cross-cutting issues**

Format:

- Short introductory, problematizing talks by the resource persons on each cross-cutting issue;
- Breakout group discussions on these issues in two steps: 1) identify main lessons learned from our experience and challenges and opportunities to be expected in the future; 2) synthesize our understanding of this issue as part of an integrated landscape approach to REDD.

#### **Incentives for sustainable production and sustainable livelihoods**

For each theme, we should work in advance to formulate one or more key issues, and specific questions for the group to work on. This work should be refined at the end of Day 1.

Each group should be facilitated by the corresponding resource person.

Followed by a Plenary discussion to socialize the groups' works and carry out a short debate on each one to reach a shared vision on the main issues.

## **Wednesday, Oct 22: Designing a shared financing strategy for our work on REDD**

### **Activity 4: Panel on financing for REDD+**

Format: 2 hour plenary session with 3-4 presentation of resource persons emphasizing different aspects of financing for REDD+, followed by a discussion

### **Activity 5: Breakout group discussions to design proposals for a shared financing strategy**

Format: 2 hour breakout group discussion in two steps: 1) develop shared vision on main challenges and opportunities, based on the previous discussion in the Plenary; 2) design proposals for our financing strategy. For each step, the groups will have 1-2 specific questions to work on.

Followed by a 1h30 plenary session to socialize and discuss the conclusions of the breakout groups.

- 2) joint acquisition strategy to access multilateral and bilateral funds as well as private sector finance.
